

Minutes School Board Meeting FY2023 Budget Proposal Adoption & Appointment of Interim School Board Member Greene County Schools WMHS Performing Arts Center February 23, 2022

Mr. Sansom called the meeting to order at 7:05 p.m. in the William Monroe High School Performing Arts Center.

Mr. Sansom requested a motion to approve the agenda. Mr. Taylor made a motion to approve the agenda as presented. Mr. Tooley seconded. No discussion. All Ayes, motion carried.

Dr. Whitmarsh presented action item #11-1196, FY2023 Budget Proposal Adoption. Dr. Whitmarsh stated the board will take action tonight on the FY2023 Budget Proposal. She shared that the budget proposal was in the packet. Dr. Whitmarsh shared the changes since the last presentation which include health insurance renewal is flat so no additional increase, initial House and Senate budget proposals, and Governor Youngkin has not released his budget proposal. Dr. Whitmarsh stated her recommendation was to approve the FY2023 budget in the amount of \$47,099,556.
